MTL DOGS –REGISTRATION FORM

1. **OWNER** AGREES TO PAY THE RATE OF SERVICE RENDERED BY **Montreal Dogs** WILL PICK UP HIS/HER PET AT MONTREAL DOGS LOCATION. **NO REFUND ON PREPAID DAYCARE PACKAGES.**
2. TAKING INTO CONSIDERATION THE SPECIAL NATURE OF THIS AGREEMENT, THE **OWNER** FURTHER AGREES BY THE PRESENT TO PAY, ACCORDING TO THE PRICE LIST MENTIONED, ALL COSTS AND CHARGES FOR SPECIAL SERVICES REQUESTED AND NECESSARY, AND ALL VETERINARIAN COSTS FOR THE PETS IF NECESSARY DURING THE SAID PETS STAY IN THE CARE OF **MONTREAL DOGS.**
3. **OWNER** FURTHER AGREES THAT THE PET SHALL NOT LEAVE **MONTREAL DOGS** LOCATION UNTIL ALL CHARGES ARE PAID TO MONTREAL DOGS BY THE **OWNER.**
4. **MONTREAL DOGS** AGREES TO EXERCISE DUE DILIGENCE AND REASONABLE CARE AS WELL AS KEEP THE PREMISES SANITARY AND PROPERLY ENCLOSED. SHOULD ANY PET BECOME ILL OR SEEM TO BE IN NEED OF MEDICAL ATTENTION, MONTREAL DOGS RESERVES THE RIGHT TO ADMINISTER AID AND TO USE ANY AVAILABLE VETERINARIAN AT THE **OWNERS** SOLE EXPENSE.
5. THE **OWNER** MUST PROVIDE VALID PROOF OF UP TO DATE VACCINATIONS OF HIS PET. THE FOLLOWING VACCINES ARE OBLIGATORY" RABBIES, DISTEMPER, PARVO AND BODETELLA (DHLPP + RABBIES). VALID PROOF MUST BE PRESENTED BEFORE THE PET CAN BE DROPPED OFF AT **MONTREAL DOGS** LOCATION. THE **OWNER** ALSO AGREES TO MAINTAIN VACCINATIONS AND TO KEEP **MONTREAL DOGS** APPRAISED OF ANY UPDATES.
6. IN THE DOGGIE DAYCARE SERVICE PROVIDED BY **MONTREAL DOGS**, THE **OWNER** ATTESTS THAT THE PET HAS BEEN SPAYED OR NEUTERED.
7. **THE OWNER** ATTESTS THAT THE PET IS IN GOOD HEALTH WHICH MEANS THAT THE PET HAS NOT HAD A COMMUNICABLE DISEASE IN THE PAST 30 DAYS, AS WELL AS THAT THE PET HAS NOT HARMED OR SHOWN ANY AGGRESSION OR THREATENING BEHAVIOUR TOWARDS ANY PERSON OR ANY OTHER PET.
8. **MONTREAL DOGS** ALWAYS RESERVES THE RIGHT TO REFUSE ANY PET FOR ANY SERVICES AT ANY TIME AT ITS SOLE DISCRETION, AT THE SOLE EXPENCE OF THE **OWNER.**
9. THE **OWNER** AGREES THAT THE PET WILL BE PICKED UP BY THE **OWNER OR A PRE-APPROVED OWNER CONTACT** ON THE ESTIMATED DATE OF DEPARTURE INDICATED IN THE REGISTRATION FORM. LATE CHARGES WILL BE EXECUTED IF NECESSARY, ACCORDING TO THE PRICE MENTIONED.
10. IF THE **OWNER** DOES NOT RETURN TO **MONTREAL DOGS** LOCATION ON THE AGREED UPON DATE OF DEPARTURE IN ORDER TO RETRIEVE HIS/HER PET AND PAY ALL CHARGES INCURRED BY THE SAME, **OWNER** AGREES THAT **MONTREAL DOGS** HAS THE RIGHT AND WILL BE AUTHORIZED BY THE **OWNER** TO REMIT THE SAID PET TO A PUBLIC ORGANISM THAT PROTECTS PETS, 72 HOURS AFTER THE ESTIMATED DEPARTURE DATE . ALL CHARGES INCURRED BY **MONTREAL DOGS** WILL BE THE SOLE RESPONSIBILITY OF THE **OWNER.** IT IS ALSO UNDERSTOOD THAT **MONTREAL DOGS** WILL DURING THE 72 HOUR DELAY TRY TO CONTACT **OWNER** BY MEANS PROVIDED IN THE REGISTRATION FORM: TELEPHONE NUMBER, EMERGENCY TELEPHONE, NUMBER AND CONTACT.

THE **OWNER** AGREES THAT THEIR PET MAY BE VIDEOTAPED, PHOTOGRAPHED AND RECORDED. **MONTREAL DOGS** SHALL BE THE EXCLUSIVE OWNER TO THE RESULTS AND ALL PROCEEDS OF SUCH TAPINGS, PHOTOGRAPHY AND RECORDINGS WITH THE RIGHTS, THROUGHOUT THE WORLD, AN UNLIMITED NUMBER OF TIMES IN PERPETUITY, TO COPYRIGHT, TO USE AND TO LICENSE TO OTHERS IN ANY MANNER. THE OWNER FURTHER AGREES THAT THE PET MAYBE USED WITHOUT ANY MONETARY COMPENSATION TO SAME IN ANY AND ALL MEDIA AND IN PROMOTION, ADVERTISING, SALE, PUBLICIZING, AND EXPLOITATION OF MONTREAL DOGS.
12. BY SIGNING THIS AGREEMENT AND LEAVING HIS/HER PET WITH MONTREAL DOGS, THE **OWNER** CERTIFIES TO THE ACCURACY OF ALL THE INFORMATION GIVEN ABOUT THE SAID PET.
13. THIS AGREEMENT CONTAINS THE ENTIRE AGREEMENT BETWEEN THE PARTIES, ALL TERMS AND CONDITIONS OF THIS AGREEMENT SHALL BE BINDING ON THE HEIRS, ADMINISTRATORS, PERSONAL REPRESENTATIVES AND ASSIGNS OF THE **OWNER AND MONTREAL DOGS**.
14. THE **OWNER** RECOGNIZES THAT **MONTREAL DOGS** GRANTS HIM SUFFICIENT DELAY TO BECOME AWARE OF ALL THE TERMS AND CONDITIONS OF THE AGREEMENT BEFORE SIGNING IT.

16. THE PARTIES EXPRESSLY AGREE THAT THE AGREEMENT SHALL BE DRAWN UP IN FRENCH.
